History: “The Gorin” was founded in 1960 to honor the late Bobby Gorin, the first Woodmont youngster to win the DC Junior Championship. In the same year of 1959, Bobby qualified for the DC Amateur, a rare achievement for a junior. In the following winter, Bobby Gorin died in a car accident. Bobby’s uncle Lou established the Gorin Memorial at Woodmont Country Club in 1960. The beloved Lou Gorin died in early 2009. The event has continued as the longest running of the Washington Area match play junior events.

The Bobby Gorin Memorial has been held at the Woodmont CC for 61 years, since 1960. It was unable to host in 2020 due to scheduling of the U. S. Women's Amateur and was played at the Chevy Chase Club.

- Eligibility** Any boy who has not reached his 19th birthday by midnight July 26 except that also a player must not be attending college or technical school. There will be three age groups: 16 – 18, 14 – 15, and 13 and under.
- Entry Fee** \$100.00 per player. Field is limited to the first 132 entries (including a maximum of 78 in the 16 - 18 age group). Post entries accepted subject to availability of spots. Call 410-991-7843. The Committee reserves the right to reject any entry. Lunch will be provided for the players on days one and two.
- Entry Open/Close** **Entries open Monday, March 15 at 9:00 AM and close Monday, July 19 at 6:00 PM. Refunds:** If a player withdraws by the close of entry - refund is subject to a \$20.00 admin fee. If a player withdraws after that date and time, no refund will be given.
- Format** 36 holes of stroke play for all age divisions. (two days of stroke play this year due to the ongoing pandemic)
- Schedule** **Monday and Tuesday** -18 holes of stroke play each day for all players with no cut.
- Rules of Golf** Play will be governed by the Rules of Golf as approved by the USGA and the R & A. The competition is final when the trophy has been presented to the winner or, in the absence of a prize ceremony, when all scores have been approved by the Committee.

Note – Spectators are not allowed.
- Prizes** Trophy awards will be presented to the winner and runner-up in each age division.
- Start Times** Starting times will be e-mailed to all contestants and can be obtained via <http://www.wmgagolf.org> shortly after close of entries.
- Caddies/ Carts** **Caddies, or golf carts are not allowed for the competition.** Push carts are OK – bring you own.
- Practice** Practice rounds are **NOT** available.

If the entering player is under the age of 18, the players' parent or guardian must submit this entry on behalf of the player, and the parent or guardian agrees that he or she is executing the Participation and Liability Release Agreement on behalf of the player and is authorizing the player to participate in the Bobby Gorin Memorial on all the terms described.

**PARTICIPATION AND LIABILITY RELEASE AGREEMENT FOR THE
WMGA BOBBY GORIN MEMORIAL**

In consideration of my entry into and permission to participate in the Bobby Gorin Memorial being conducted by the Washington Metropolitan Golf Associations, I voluntarily agree to each of the following:

Assumption of Risks and Responsibility. I acknowledge that participating in the Bobby Gorin Memorial involves risks and dangers of personal injury, illness, loss or damage of many kinds, including without limitation those arising from or relating to a virus or disease, such as the SARS-CoV-2 coronavirus that causes COVID-19 (“COVID-19 virus”); heat stroke or other health-related risks; lightning strike; golf cart or automobile accident or other types of accidents; being struck by a ball, club, or other object; snake or other animal bites or injuries; or sports injury (collectively, “Event Injuries”).

I voluntarily assume all risks relating to and accept sole responsibility for any and all such Event Injuries that I may incur in connection with my participation in the Bobby Gorin Memorial.

Release of Claims, Covenant Not to Sue and Indemnification. I hereby release the Washington Metropolitan Golf Association (WMGA) and the Woodmont Country Club and all of their respective employees, volunteers, officers, directors, agents and representatives (collectively, the “Released Persons”), of and from any and all claims, liabilities, actions, damages, costs or expenses arising out of or relating to Event Injuries or my participation in the Bobby Gorin Memorial whether resulting from negligence or otherwise (collectively, “Released Claims”).

I agree not to sue the Released Persons for such Released Claims. I agree to indemnify, defend and hold harmless the Released Persons in connection with such Released Claims, including without limitation for any attorney’s fees or expenses they incur in enforcing this Agreement.

Agreement Relating to COVID-19 Virus. Without limiting the foregoing, I acknowledge the contagious and harmful nature of the COVID-19 virus and voluntarily assume the risk that I may be exposed to or infected by this virus by participating in the Bobby Gorin Memorial.

I also certify that, to my knowledge, I am not now infected with the COVID-19 virus, am not experiencing symptoms that may be associated with this virus, and in the past 14 days have not been in close contact with anyone infected with this virus. I agree that this certification remains in effect from my entry until the end of my participation in the Bobby Gorin Memorial, and I will inform the WMGA immediately if any part of these certifications ceases to be true during this time.

Agreement to Follow Rules, Policies and Procedures. I acknowledge that the WMGA may implement and enforce rules, policies and procedures in connection with the Bobby Gorin Memorial, including without limitation to ensure appropriate conduct by participants and to implement and comply with public health and safety requirements, guidelines and/or recommendations, whether relating to the COVID-19 virus or otherwise (collectively, “Event Rules”).

I agree to comply with all such Event Rules. I also agree that if I fail to comply with any Event Rules or commit any misconduct, or if my participation might pose any health risk to others, all as determined by WMGA in its sole discretion, the WMGA may refuse to allow me to participate in the Bobby Gorin Memorial, without any refund to me or any liability to the WMGA.

Severability and Waiver. If any provision of the Agreement is found unenforceable in whole or in part, the rest of the Agreement shall remain fully enforceable. A failure by the WMGA to enforce any provision shall not constitute a waiver of that provision or any other provision.

Agreement for Minors. If the participant is a minor child under age 18, this Agreement must be executed on his or her behalf by a parent or guardian. In doing so, the parent or guardian agrees that all provisions of this Agreement apply to all the minor’s parents or guardians.

By submitting this registration, I have executed this Participation and Liability Release Agreement and agreed to all its terms and conditions. If under 18, registration must be submitted by parent or guardian.
